This matter having come before the Court on PLAINTIFF'S *UNOPPOSED* MOTION TO AMEND THE COURT'S JUNE 4, 2009 MINUTE ORDER, and after reviewing the Motion and the arguments therein, hereby GRANTS Plaintiff's Motion and amends the Court's June 4, 2009 Minute order to read as follows:

The Plaintiff appeared through counsel LeeAnn Richey and Alissa Gardenswartz of the AG's office, the Defendants all appeared with counsel Ty Gee for Stephenie Gardner, Kevin McGreevy for Robert Warren and Livingston Keithley for Mary Warren, the Custodian appeared through counsel Jack Tanner. The Court heard argument on the Motion for EMC and will enter a written Order allowing limited EMC. The Plaintiff orally amended its request for contempt to remove its request for punitive sanctions at this time, and requested that the Court impose whatever remedial sanctions were required to obtain compliance with the Court's Order Appointing the Custodian. The Plaintiff also stated that it was not opposed to the Court imposing jail time as a remedial sanction. The Defendants were advised and the matter was set for a hearing on the contempt citation on July 9 and 10, 2009 at 8:30 A.M. in Division 404. The Plaintiff will disclose witnesses and exhibits on or

before June 18 and the Defendants on or before June 25. The Custodian will not participate other than as a witness.
