1. This Court entered a Stipulated Order Appointing Custodian and for Preliminary Injunctive Relief on December 16, 2008;
2. Based on the State's showing in the Motion, there is cause to believe Defendants Mary Warren, Robert Warren and Stephenie Gardner have not complied with the Order and that, to date, they remain in disobedience of the Order.
