<i>Amended</i> ORDER TO PRESENT AND FILE CLAIMS	

THE COURT, upon the custodian's Motion for an Order and presentation of filing of claims,

HEREBY ORDERS that such Motion is Granted.

All persons and firms having claims or demands against the Colorado Humane Society & S.P.C.A., Inc. are required, on or before the 9th day of August, 2009 to file their claims with Waverton Group, LLC, custodian, 4101 East Louisiana Avenue, Denver, Colorado, 80246, under penalty of having said claims denied by this Court if not timely filed and not being allowed to use the facts that underlie the unfiled claim as an offset or counterclaim to any action brought by the custodian.

In any such claim, the claimant shall certify under penalty of perjury the following information:


- a. Complete name;
- b. Complete address;
- c. Telephone number;

- d. Fax number;
- e. E-mail address;
- f. The exact amount of the claim as it existed on December 16, 200~~9~~⁸;
- g. The date the claim arose;
- h. The preference and repayment or priority status of the claim;
- i. The exact nature and value of any security held by any claimant in support of the claim;
- j. Whether the claim bears interest and, if so, the basis for claiming interest;
- k. A description of the basis of the claim;
- l. Documents in support of the claim;
- m. The nature and value of any offset or counterclaim; and
- n. Whether the claimant has appointed an attorney-in-fact on behalf of the claimant and, if so, the full identity of the said attorney-in-fact.

Further, any party shall, before filing, dismiss any other claims pending against Colorado Humane Society & S.P.C.A., Inc. in any other court or proceeding and shall verify to this Court, under penalty of perjury, that such claims have been dismissed without prejudice. A party that persists in pursuing actions against Colorado Humane Society & S.P.C.A., Inc. in other courts or proceedings shall have its claim, counterclaim, or offset denied and disallowed by this Court, and shall not be allowed to participate in distributions from this case.
